Supporting Organisations and Advisory Committees

Address Supporting Organisation (ASO) – 1999
Government Advisory Committee (GAC) – 1999
Root Server System Advisory Committee (RSSAC) - 1999
At Large Advisory Committee (ALAC) – 2002
Security and Stability Advisory Committee (SSAC) - 2002
country code Names Supporting Organisation (ccNSO) – 2003
Generic Names Supporting Organisation (GNSO) - 2003

- Uniform Domain-Name Dispute-Resolution Policy (UDRP) approved by the ICANN Board;
- For resolution of disputes regarding the registration of Internet domain names, protecting trademarks in the domain name sphere.

2000-2002 First Round of new gTLD Expansion

- 7 new gTLDs: .biz, .info, .name, .pro, .aero, .coop, and .museum
- First expansion of the DNS system since the 1980s (.com, .edu, .gov, .int, .mil, .net, and .org)

2002 ICANN Reform

- Massive change in structures of ICANN community, organization and operations of ICANN board and organization
 - Creation of the Ombudsman's Office;
 - Enshrinement of ICANN's mission and core values into the ICANN Bylaws;
 - Overhaul of the bylaws, generally;
 - Creation of the ccNSO;
 - Creation of the ALAC;
 - Transformation of the DNSO into the GNSO;
 - Refinement of ICANN's Policy Development Process;
 - Reform of the Nominating Committee

2009/2010: Internationalised Domain Names

- Process launched November 2009;
 - First IDN requests: Egypt, Russian Federation, Saudi Arabia, United Arab Emirates;
 - Approved in January 2010
- Internet accessibility across diverse scripts and languages

DNSSEC Introduced to Root Zone

2012: New gTLDs & New Rights Protection Mechanisms

- Almost 2000 applications,
- 1200+ added to root zone
- New Rights Protection Mechanisms
 - Trademark Clearinghouse
 - Uniform Rapid Suspension System
 - Trademark Post-Delegation Dispute Resolution Procedure

2016: IANA Stewardship Transition

- Transfer of the Internet Assigned Numbers Authority (IANA) functions stewardship from the National Telecommunications and Information Administration (NTIA) of the United States Department of Commerce to the global multistakeholder community
